Eligibility

The Colorado Clean Energy Fund LED Lighting Loan is available to building owners based in Colorado. Borrowers must be in Good Standing with Secretary of the State and demonstrate one year of positive cash flow in the last five years. Businesses must have at least one employee - and no more than 99 employees - and have a Debt Service Coverage Ratio (DSCR) of 1:1 since February 29, 2020. Applicant must have been in business for at least one year and provide one year of tax returns for any single year from 2019-2022.

Work must be performed by an NEIF-Approved Contractor and qualify for an LED Lighting Loan.
