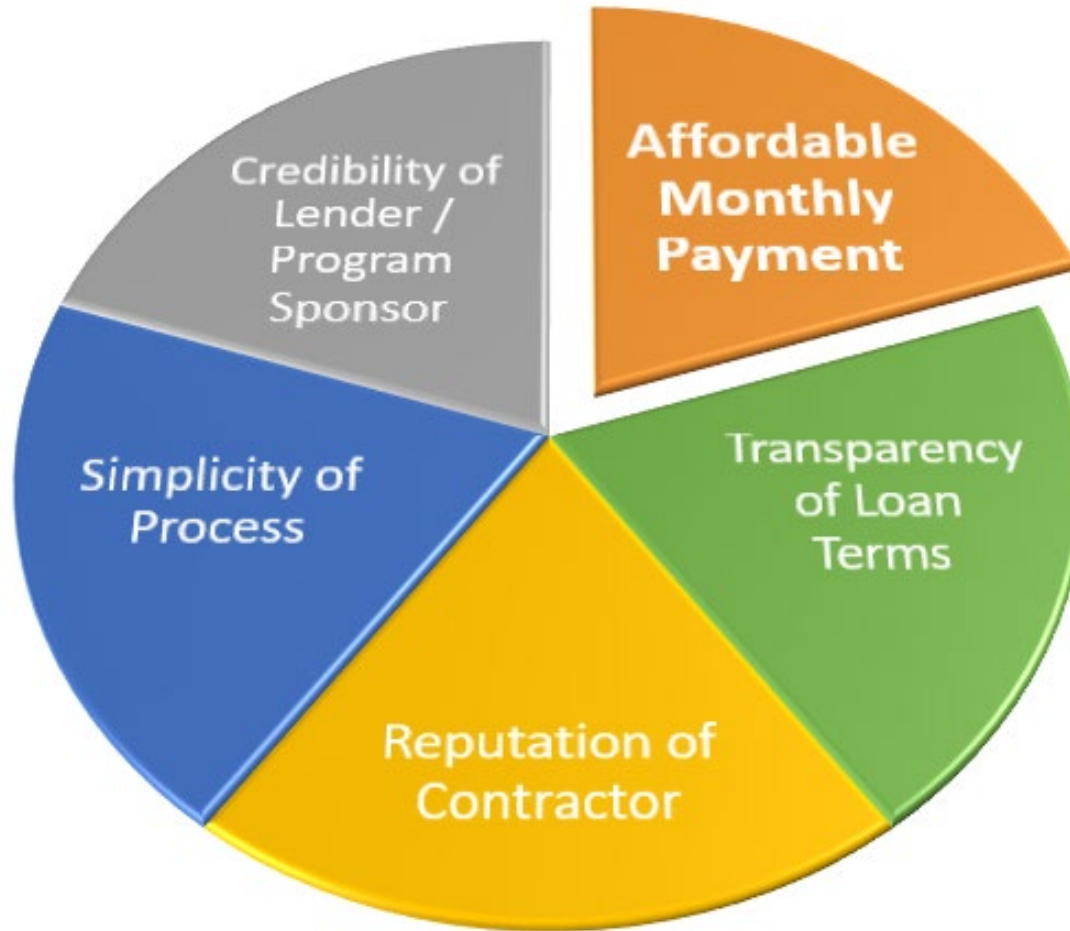

# KEEP Home Energy Loan – Overview

---

- Pennsylvanians can “Go Greener, Affordably” with fixed monthly payment financing for improvements that make homes more energy efficient.
- Eligible improvements include ENERGY STAR rated measures such as heating and cooling, windows, doors, air sealing and insulation and other energy-saving improvements (qualification certified by contractor).
- Work must be performed by NEIF-Approved contractors who have been vetted for financial stability and ethical business practices.
- Approximately \$10 million in available funding for first phase.
- Supported by the Pennsylvania Energy Development Authority (PEDA)’s Energy Accelerator Program.
- Administered by NEIF, the National Energy Improvement Fund, a Certified B Corp Pennsylvania energy efficiency lender.
- 100% financing available, instant credit decisions, easy paperless process and responsive communication with you and your contractor.

# KEEP Home Energy Loan – Rates and Terms

- Unsecured installment loan
- 3, 5, and 10 Year Terms
- **Maximum project size \$25,000**
- Loan amounts from \$2,500 to \$25,000, depending on borrower’s credit
- 8.99% fixed rate  
(current rate as of April 2024)
  - Rate is locked in for full term when loan is made
- No penalty for pre-payment
- No consumer fees
- **No contractor fees**

# KEEP Home Energy Loan – Eligible Borrowers

---

- One to four unit primary or secondary (vacation) home, Pennsylvania-deeded properties.
- Owner-occupied, no investment properties, must be affixed to a permanent foundation.
- No lien is filed on the property.
- Properties owned by or held in trust are not eligible.
- Applicants must meet all credit guidelines.

# KEEP Home Energy Loan – Eligible Improvements

- Work must be performed by a NEIF-Approved Contractor **who must certify that the qualifying improvements are listed at [energystar.gov/products](http://energystar.gov/products) at time of installation.**
- Qualifying improvements are limited to the categories shown below.
- Financing may include all related work required for installation.
- **Maximum project size is \$25,000.**

# Contractor Certification of Eligible Improvement

- The qualifying improvements (make and model number) must be listed at <https://www.energystar.gov/products>.
- Use the “Product Finder” to ensure that the improvement you are installing qualifies as ENERGY STAR.
- The contractor must self-certify that the improvements qualify when they sign the completion certificate. This is a qualification for funding. Installations may be subject to quality assurance verification.
- Non qualifying improvements and larger projects may be eligible for NEIF’s standard EnergyPlus financing.

## "Know Before You Go" Credit Pre-Screen and Easy Application

- You can credit pre-qualify your customer with just a name and address - know before you go!
- Won't impact customer credit.
- To have your customer apply give them monthly payment options and use your company's custom NEIF Financing Gateway on your phone, tablet or website.

## Instant Credit Decision. We Take Care of the Details

- Your customer will receive an immediate credit decision and you can view it instantly on your NEIF Contractor Portal.
- We will also email you and your customer.
- Upload a picture or PDF of customer contract or proposal to their NEIF Contractor Portal as soon as possible. **Must show manufacturer and model number of qualifying improvements.**
- Our Energy Lending Specialists assist the customer and contractor to expedite final approval and funding

## Fast Contractor Funding

- Electronic loan docs are sent directly to the customer upon final approval, typically as soon as the contractor's proposal has been uploaded.
- Contractor can review the status of customer applications at any time by logging into their portal.
- Customer and contractor electronically sign off on job completion.
- **Contractor must certify that the qualifying primary improvements are listed at [energystar.gov/products](http://energystar.gov/products)**
- NEIF funds contractor directly via ACH within 2 business days.

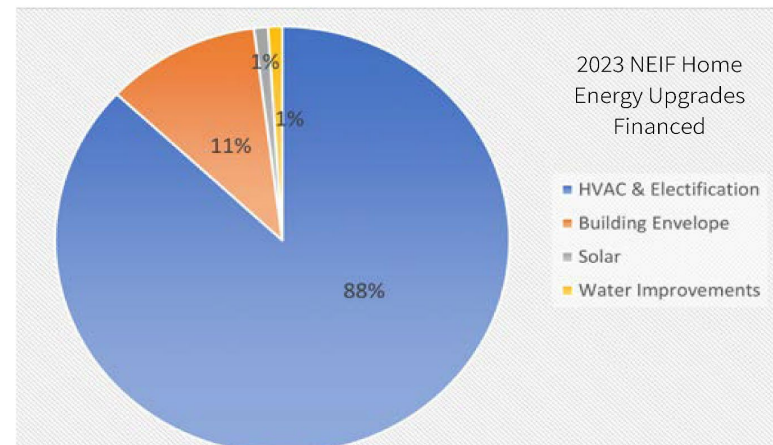


## NEIF'S RAPID GROWTH IN FINANCING OF ESSENTIAL RESIDENTIAL & COMMERCIAL EFFICIENCY PROJECTS

Affordability is the greatest impediment to the adoption of home and building energy efficiency upgrades. They are expensive and often unexpected. Rebates only cover a small portion of the cost and traditional financing is typically short term "teaser" rates, high cost to contractor or a cumbersome loan process. NEIF is focused on improving the delivery channel, increasing affordability and aiding contractor cash flow.

## ESSENTIAL ENERGY UPGRADES & ELECTRIFICATION ARE ATTAINABLE AND CAN DRIVE THE MARKET

Core upgrades - heating and cooling (HVAC), insulation, roofing, lighting - are what drives most demand. Electrification (heat pumps, generators, storage) is becoming a dominant trend. While solar is an option for some, NEIF focuses on working with contractors, utilities, distributors, and state "green banks" to increase the uptake of core improvements. In 2023, 88% of financed home improvements were for HVAC and electrification.
